SMERU complied with an invitation from the British Embassy Jakarta on Thursday, 13 July 2023, to meet with the Foreign Secretary of the United Kingdom, James Cleverly TD VR, during his visit to Jakarta. The topic of discussion in the meeting centered on Indonesia's science and innovation landscape. SMERU's Deputy Director of Research and Outreach, Athia Yumna, had the privilege of introducing SMERU and the Institute's work in bridging research with policy.



SMERU and UNICEF Indonesia undertook eight studies to raise government and stakeholder understanding of specific children-related issues in Indonesia. SMERU presented the study results and the plan to disseminate the results to the Ministry of Women's Empowerment and Child Protection on 26 July 2023. The Ministry's Secretary, Pribudiarta Nur Sitepu, met with and listened to the presentation by SMERU's Deputy Director of Research and Outreach, Athia Yumna.



SMERU warmly welcomed the visit of the University of Antananarivo and the ASTA Research Centre on 14 July 2023. The two institutions from Madagascar expressed their interest in collaborating with SMERU in the future, particularly in research on poverty, inequality, and improving the quality of education.
