In 2019, particularly right before the pandemic, SMERU conducted a forum on Toward an Inclusive Digital Economy and a study of Inclusive Digital Economy in Indonesia. We believe that various opportunities to drive digital transformation in all sectors need to be optimized, not only to accelerate economic growth and the postpandemic recovery, but also to reduce inequality and create a more equitable welfare. Acceleration of economic growth has always been the main goal of digital transformation, but it often pays little attention to the equity aspect of the benefits received by different groups of people.

Therefore, we raised an issue of the importance of encouraging a more inclusive and fair digital transformation in Indonesia as the main theme of today's discussion. Our research team has captured the latest trends and responses, identify various challenges—particularly related to various gaps that still exist, review policies and strategies that have been initiated and implemented, and develop recommendations to support a more equitable digital transformation in Indonesia.

In this morning's discussion, we will present the results of our analysis and thoughts on how to "Accelerate Inclusive and Fair Digital Transformation to Anticipate Challenges Facing the Future of Work" and discuss with various parties regarding solutions so that digital transformation can be optimized to reduce poverty and inequality. This discussion is expected to provide a deeper understanding of the challenges, both existing and new ones that continue to emerge, currently faced by Indonesia in encouraging inclusive digital transformation. We hope that this understanding will trigger consolidated efforts from the government, development partners, nongovernmental organizations, academics, researchers, and practitioners to implement policies and strategic steps to accelerate the postpandemic recovery and create more equitable welfare through inclusive digital transformation.

In this year's policy forum, SMERU is also collaborating with CIPPEC Argentina and GIZ Germany to raise discussions at the global level, particularly regarding the future of work in the Global South. This discussion aims to continuously support the efforts of the G20 countries after the Indonesian Presidency this year. After the morning session, which discusses the Indonesian case, this forum will continue with a broader discussion on the challenges faced by the Global South by drawing on the experiences of several countries, such as Brazil, India, and African countries.

Finally, on behalf of SMERU, we would like to thank GIZ, especially Jakob Lessin (Future of Work Advisor) and Sascha Heller, and CIPPEC, especially Ramiro Albrieu (Senior Researcher) and Megan Ballesty (Future of Work Consultant), for their support and cooperation.
