Through a partnership with the Ministry of Education and Culture, ADBI, the Tanoto Foundation, Surala, JPAL, and SMERU, are researching how personalized technology-aided instruction can help improve student foundational skills in math at the junior high school level and support teachers to stimulate students' higher-order thinking skills. The interventions have two components: the use of technology and training on its use for teachers (high tech) and developing teacher training programs on pedagogical approaches to foster students' higher-order thinking skills (high touch).
